1. QD calculated on monthly lifting basis on all prime, non-prime grades except Utility,sweepings, waste grades and powder.
2. Deemed Exports quantity cannot be clubbed with the domestic sales quantity for calculation of eligibility or discount.
3. Combined domestic off-take of Ex-Plant, Ex-DOPW and any other depot of Nayara shall be considering for QD calculation.
4. QD shall be settled by credit note after completion of lifting in the succeeding month.
