Quantity Discount (QD):

1. QD calculated on monthly lifting basis on all prime, non-prime grades except Utility, sweepings, waste grades and powder.
2. Deemed Exports quantity cannot be clubbed with the domestic sales quantity for calculation of eligibility or discount.
3. Combined domestic off-take of Ex-Plant, Ex-DOPW and any other depot of Nayara shall be considering for QD calculation.
4. QD shall be settled by credit note after completion of lifting in the succeeding month.
5. Below are the slabs for QD:

Delayed Payment Charges:-
